COVID-19 NO. 4 YEAR 2020 SPECIAL ANNOUNCEMENT

**RECOVERY MOVEMENT CONTROL ORDER (RMCO)
STARTING FROM 10 JUNE 2020 UNTIL 31 AUGUST 2020**

1. BACKGROUND

Given the current situation of the COVID-19 outbreak in Malaysia and taking into account the recommendations put forth by the Ministry of Health (MOH), the **Right Honorable Prime Minister of Malaysia announced on 7 June 2020 (Sunday) of the implementation of the Recovery Movement Control Order (RMCO) starting from 10 June until 31 August 2020.** UUM adheres to the directive that is subject to the Federal Government Gazette of the Prevention and Control of Infectious Diseases (Measures within the Infected Local Areas) 2020 under the auspices of the Prevention and Control of Infectious Diseases Act 1988.

Although several restrictions have been lifted as the nation enters the RMCO, **ALL STAFF AND STUDENTS** are required to adhere to the directives and Standard Operating Procedures (SOP) issued by the National Security Council (MKN) and the Ministry of Higher Education (MOHE) as well as other self-monitoring by the respective Departments.

Staff and students are also required to continue to adhere to any directives issued and to be perceptive to the notifications which will be made by the University Management throughout the implementation of the RMCO.

2. IMPLEMENTATION

This announcement should be read together with the notices, guidelines and directives that have been issued to all staff and students by the University Management pertaining to the Movement Control Order (MCO) starting from 18 March 2020.

3. EFFECTIVE DATE

This announcement goes into effect on 10 June 2020 and is subject to the directive and circular issued by the Public Service Department (PSD), the Ministry of Health (MOH) and the Ministry of Higher Education (MOHE) or any other authority designated by the Malaysian Government from time to time.
