AN INTRODUCTION TO CASE WRITING WORKSHOP

Synopsis

The case method is a form of education that is discussion-based and in line with student-centred learning. Cases are a particular form of instructional material that must be authored by a skilled case writer. Nearly all cases are centred on one overarching question: What should the protagonists do? Writing quality cases requires the case writer to fully understand the subject matter acquired through interviews with business executives and careful scrutiny of business documents. Faculty members often spend weeks at the company that is the subject of the case, detailing the background of the situation, the immediate problem or decision, and the perspectives of the executives. This introductory case writing workshop will provide participants with an understanding of case-writing techniques to help them develop the requisite skills.

Learning Outcomes

By the end of the workshop, participants will be able to:

- Identify and initiate a case writing project
- Develop skills in organising a case writing project
- Recognise the opportunities and challenges in writing effective cases
