With reference to the matter above, Universiti Utara Malaysia has agreed to renew the health insurance scheme for its staff and their dependants, which will expire on 29 June 2017. **The renewed health insurance scheme, which will be effective from 30 June 2017 to 29 June 2018, provides coverage only for members of staff between the ages of 18 and 63 years (permanent staff, tutors, contract staff and visiting academic staff) and their dependants (spouse: between the ages of 18 and 63 years; children: between the ages of 15 days and 23 years - full-time students).**

For the period beginning 30 June 2017 until 29 June 2018, UUM members of staff and their dependents will continue to be protected under the insurance coverage provided by the Etiqa Takaful Company.
