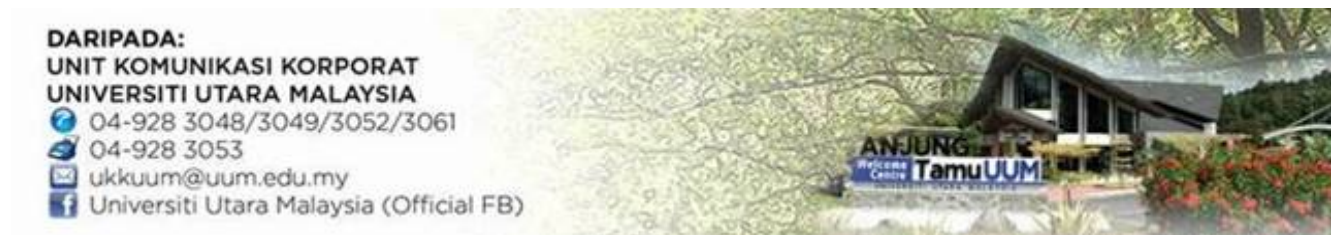
Dato' Prof. Dr. Sudin is appointed by the Honorable Minister of Education Malaysia, Dr. Maszlee Malik.
